# Public Law, Separation of powers, Administrative, Ordinary, Private, Duality, Administrative courts, Judicial court.

The Ordinary judiciary handles cases related to individuals and private entities under civil, criminal, or commercial law.

Disputes involving government actions or decisions are reviewed by the Administrative judiciary.

In Algeria, the division between these two court systems is known as the Duality of jurisdiction.

Matters concerning personal status, marriage, and inheritance fall under the authority of the Judicial courts.

When a citizen sues a public authority for wrongful action, the case is heard by the Administrative courts

The Separation of powers ensures that no single judicial body has control over both private and public law matters.

The ordinary courts apply Private law when resolving conflicts between private parties.

Administrative courts ensure that governmental institutions act within the limits of Public law.
